RE: Lakefront Improvements Project – Community Meeting #1 Summary

On Wednesday, October 25, 2023, representatives from DCG/Watershed and the City of Lake Forest Park facilitated a public workshop to engage the residents and community members of Lake Forest Park in the predesign stage of the lakefront improvements project. The workshop occurred from 5:30-7:30pm in Council Chambers at Lake Forest Park City Hall. Approximately 100 community members, city representatives and staff, and members of the design team attended the session.

A summary of the feedback and comments received is provided below. Note, no summary is provided for Exercise 1: Coloring Book Page.


Exercise 2: Precedent Examples for Small Lakefront Structure Program




Exercise 5: Community Conversation / Vision Prompt

Analysis: Diagramming Exercise

Waterfront / Dock

- Initial desire to place low-decibel activities (kayaking, wildlife viewing) on west side of existing dock, more active activities (swimming, paddleboarding) on east side of existing dock, stayed consistent throughout the meeting
- Small dock addition proposed, then revised to circular dock closer to shoreline
- Dock layout further revised to connect two existing docks on the south, additional lateral docks prosed on eastern existing dock extending west. The resulting encircled shoreline between the two existing docks proposed for swimming / wading
- Towards the meeting's conclusion swim docks were proposed both in the encircled water area as well as to the east of the existing eastern dock.
- Desire for increased native flora/fauna added to the shoreline of the western existing dock (fish, raptors, grasses)
- Suggestion for an ADA kayak/canoe launch on the dock
- Discussion included multiple conversations about the concern about water-based actives being located too close to Lyon Creek to the west, impacting the habitat and ecosystem of the creek, and too close to the adjacent residential uses to the east.
 - Suggestions included minimizing the footprint of a beach/kayak launch area to clearly define where those activities should be taking place and centering it on the property and buffering with vegetation on both the Lyon Creek side as well as the residential property to the east.
 - Discussion about the potential to consolidate the two docks into one dock and center it between the existing docks to minimize impacts on Lyon Creek and the residential property to the east.
- Discussion between multiple individuals about the value of a dock vs. both a dock and a beach for uses like swimming, launching boats, etc. If the primary goal of water activity is for swimming and boat launching, these can be done with a beach and no dock at all.
 - It was mentioned that the dock should serve intentional uses like having spots to sit and view wildlife or the lake, or provide a place for people to fish. People value the passive nature of the existing Lyon Creek dock

Findings: Participants showed desire for less-disruptive activities on the western parcel (i.e., existing preserve) to promote interaction with the restored landscape. Proposed active recreation focused on the eastern site (i.e., new acquisition parcels). Participants explored ideas to expand and reconfigure the existing dock to better accommodate desired uses, such as swimming, paddleboarding, kayaking, and rowing. Community concepts included expanding the dock to feature more seating, gathering space, a

defined swimming area (such as by connecting the two existing docks), and extending the dock length to access deeper water.

Upland Site

- Opportunities to gather at the shoreline proposed at the existing eastern dock lawn (picnic, shelter, grilling, firepit, lawn games)
- A natural seating area with seating and shade canopy proposed upland of the waterfront lawn, this area was later proposed to include an outdoor shower and evergreen screening
- Central lawn proposed to be replaced by edible food garden and food washing station
- Interpretative elements suggested at the smaller existing building adjacent to the central food lawn, to include Lushootseed language
- Places for art, additional interpretation, and screening proposed throughout the restored stream section of the site
- Kayak storage suggested near the water
- Proposed community center in the large existing building


Findings: Throughout the meeting, participation in the activity demonstrated more support for expansion of recreational activities, development, and gathering on the eastern parcel (i.e., new acquisition), reserving the western portion of the site for restoration, creek preservation, habitat, interpretation, and art. The areas just upland of the water's edge were often programmed for resource-based activities and recreation, such as gardening and nature-based children's play.

Beach Dr NE

- Initial suggestions to place picnic areas and art elements at northeast corner of the site at the location of the proposed removed buildings
- Proposed parking for the site was placed at the northeast corner of the site where the existing buildings are to be removed, with the parking footprint expanding south over the course of the meeting, the end result included the addition of shrubs and evergreen screening elements
- Bike parking located centrally along Beach Drive NE, which also included restroom facilities.

Findings: Participants showed a desire to locate bicycle parking and rider-friendly facilities adjacent to the existing parking and driveway areas, often using the footprint of the existing buildings planned to be removed. ADA-compliant, standard, and bicycle parking were proposed.
